DESCRIPTION

This stretch sweatshirt with a stand-up collar made of the ARDON®TOPLYRON technical material, which is of extreme high quality, keeps a stable shape, and is wrinkle-free and pleasant to the touch at the same time. The material is not susceptible to static electricity due to its ability to repel dust particles. The sweatshirt has an anatomically shaped functional SLIM FIT cut, is equipped with a comfortable continuous zip fastening with a chin guard, 1 zipper chest pocket and 2 zipper side pockets. The chest pocket is located on the right side to allow for branded printing. For increased safety of movement, the sweatshirt has functional high-visibility elements.

This personal protective equipment is in conformity with the requirements of the following harmonised standard:
