DESCRIPTION

The inside is combed, pleasant to the touch, while the outer surface is soft with a special anti-piling surface treatment that prolongs durability. The sweatshirt has attractive dynamic lines on the zippered chest pocket, a practical cut with a zipper and a chin cover, the stand-up collar keeps your neck warm, two lower zippered pockets. It completely adjusts to all motion thanks to its ergonomically slim fit with pre-shaped sleeves. It is suitable for demanding work, sports, and outdoor activities.
